**MEMORANDUM**

IN RE: COVERAGE OF DIVISION "G" CASES UNTIL JUSTICE PERRY'S  
SUCCESSOR IS SELECTED

DATE: MARCH 12, 2009

Because of the elevation of our colleague, Judge James E.C. Perry, to the Florida Supreme Court, the remaining judges in the civil and family division have agreed that on an interim basis those cases will be handled in the following manner whenever there is not a senior judge appointed:

1. Division "G" cases that end in 1, 2, or 3 will be handled by Judge Nancy Alley.
2. Division "G" cases that end in 4, 5, or 6 will be handled by Judge Alan Dickey.
3. Division "G" cases that end in 7, 8, or 9 will be handled by Judge Clayton Simmons.

When the case number ends in a 0 or multiples thereto, the 0 should be ignored and the number that appears before the 0 is the determinative number.

Unified Family Court Domestic Violence Injunctions will be handled in the following manner:

When Judge Perry is shown as the Injunction Duty Judge or when an injunction is assigned to Division "G" because of a previously filed case, the Petition for Injunction should be sent for review and scheduling to Judge Alley if the case number ends in 1, 2, or 3; Judge Dickey if the case number ends in 4, 5, or 6; and Judge Simmons if the

case number ends in 7, 8 or 9. The cases will continue to be assigned to Division "G" but these judges will handle the review, and if necessary, hearings on the Petition for the Injunction for Protection.

This information is for your clerks and is also being sent to court administration so that all personnel will be aware of the appropriate judge before whom to schedule matters that are assigned to Division "G".

Thank you for your help with this period in which we will be understaffed.
