Parties must appear in person, no telephonic appearances are allowed. Time Certain Motions are for one hour only and cannot be cancelled unless the matter(s) have settled. Calendar Motions are a cattle call and are in 15-30 min increments. All types of hearings must be coordinated with the other side, even Pro Se parties, before calling to set the hearing. Cross-noticing/Piggybacking is not allowed without consent from the Judicial Assistant.
