Ex Parte / Short Matters Hearings are ten minutes or less. You can not have Motions to Dismiss, Compel, or Summary Judgment at this time. Parties must appear in person, no telephonic appearances are allowed. Time Certain Motions are for one hour only and cannot be cancelled unless the matter(s) have settled. Calendar Motions are a cattle call and are in 15-30 min increments. All types of hearings must be coordinated with the other side, even Pro Se parties, before calling to set the hearing. Cross-noticing/Piggybacking is not allowed without consent from the Judicial Assistant.
