The following cases are set for trial during the two (2) week trial period beginning **MONDAY, FEBRUARY 20, 2012** before the undersigned judge in Courtroom "G", 2nd floor of the Seminole County Courthouse, 301 North Park Avenue, Sanford, Florida. Cases will be tried in the order set forth below unless special arrangements are made with the Court.

PENDING MOTIONS. All pending motions, except motions customarily raised and heard during the trial, that have not been determined prior to trial will be deemed waived. The court will not consider motions for continuance except for reasons of emergency.

TRIAL DOCKET MANAGEMENT. The trial docket is managed by the Civil Trial Coordinator, Kelley Rowland, (407) 665-4203. She will answer any questions concerning the progress of the docket. Please do not call the court or the judicial assistant concerning the docket. Attorneys and unrepresented parties have the responsibility to keep one another and the court advised of the trial status of their cases. Plaintiff's attorney is responsible to notify the Civil Trial Coordinator immediately if a case settles. All cases shall be ready to proceed with the disposition of the preceding case.


The Civil Trial Coordinator will attempt to notify attorneys and parties not represented by an attorney of the progress of the trial docket beginning approximately two days prior to the first day of trial. The Trial Coordinator has specific instructions concerning scheduling. She is not a judge and has no authority to grant continuances. Please do not ask her to exceed her authority.
